

How much will it cost me?

Fixed Price Conveyancing Package

Our New South Wales residential conveyancing (both buying and selling) is based on a Fixed Price Conveyancing Package.

These Packages range from \$1,250 +GST for smaller sales and purchases, to \$2,500 +GST for larger sales and purchases. For very large sales and purchases, we agree a fixed price by negotiation with you at the start of each matter.

These Fixed Price Conveyancing Packages apply to New South Wales conveyances of properties on a single title (excluding off-the-plan purchases), with standard finance documents.

Our prices include all general internal office costs. External out-of-pocket disbursements (eg. searches, building inspections, stamp duty, etc.) are extra.

Will & Power of Attorney Packages

Work for Wills and Powers of Attorney are charged on the basis of our normal hourly rates. The price will vary depending on the complexity of your Will and assets.



Other Private Clients Work

Generally, all other work undertaken by our Private Clients Division is completed using normal hourly rates. These rates are available on request. In appropriate circumstances, fixed price work can be provided based on firm quotes agreed by negotiation at the start of each matter.

When do I pay?

For conveyances, we require our fees to be paid on completion of your work. For Wills and Powers of Attorney, we require our fees to be paid on completion and signing of your documents. For all other work, accounts are rendered on a monthly basis, and we require our fees to be paid within 30 days of our account being issued.
